« **Game rules Extime Rewards
Paris 2024 Olympic Games** »

Article 1: Purpose

*Aéroports de Paris, a public limited company with share capital of 296,881,806 euros, registered with the Bobigny Trade and Companies Registry under SIREN number 552 016 628, having its registered office at 1 Rue de France, 93290 Tremblay-en-France (hereinafter referred to as the "**Organizing Company**"), is organizing a game with a purchase obligation on the occasion of the Paris 2024 Olympic Games on the contest.game.extime.com website (hereinafter referred to as the "**Game**").*

The Game is organized by the Organizing Company and technically operated by Artefact SAS, a simplified joint-stock company with capital of €3,813,939.90, registered with the Paris Trade and Companies Register under SIREN number

Article 2: Game dates

The Game will take place between April 15, 2024 from 12:00 p.m. (Paris time - France) and June 16, 2024 until 6:00 p.m. (Paris time - France).

Entries received after the above deadlines will not be accepted.

Article 3: Conditions of Participation

3.1 Individuals eligible to participate in the Game

Participation in the Game is open to any individual of legal age (as defined by French law), residing in mainland France, within the Game participation deadlines described in article 2 above.

Participation in the Game is excluded:

- Members of the Organizing Company's staff;
- Employees of companies controlled by the Organizing Company within the meaning of Article L.233-3 of the French Commercial Code;
- To the staff of Artefact ;
- Staff members, members or volunteers of the Paris 2024 Olympic and Paralympic Games Organizing Committee (COJOP);
- Staff members and volunteers of the International Olympic Committee (IOC), a private, not-for-profit international organization;
- Staff members and volunteers of the Olympic Foundation for Culture and Heritage;
- Close family members (parents, brothers, sisters or any other person residing in the same household within the meaning of French law):
 - o Members of the Organizing Company's staff;
 - o Employees of companies controlled by the Organizing Company within the meaning of Article L.233-3 of the French Commercial Code;
 - o Artefact staff members;
 - o Staff members, members or volunteers of the Paris 2024 Organizing Committee for the Olympic and Paralympic Games (COJOP);
 - o Members of staff or volunteers of the private, not-for-profit international organization known as the International Olympic Committee (IOC);
 - o Staff members and volunteers of the Olympic Foundation for Culture and Heritage.
- More generally, any person contributing or having contributed directly or indirectly, continuously or discontinuously to the preparation, execution and organization of the Game. The same applies to members of their immediate family (parents, brothers, sisters or any other person residing in the same household within the meaning of French law).

3.2 Nominative and unique participation

Participation in the Game is nominative and limited to one entry per physical person (same surname, same first name and same address).

Under no circumstances may the participant play under several pseudonyms, with several "Extime Rewards" accounts, or with several email addresses.

Under no circumstances may the participant play on behalf of other participants.

Any entry that does not comply with the above specifications will not be considered.

3.3 How to participate

Participation in the Game is subject to a purchase obligation.

In order to participate, and within the deadlines described in Article 2 of these rules, the participant must :

- Be a member of the "Extime Rewards" loyalty program. To become a member of the "Extime Rewards" loyalty program, participants must create an account on the www.extime.com website or on the www.parisaéroport.fr website;
- Go to Paris-Charles de Gaulle or Paris-Orly airport with a valid ticket for the day of travel;
- Make at least one (1) purchase in one of the partner boutiques listed in Appendix 1 of these rules, located at Paris-Charles de Gaulle or Paris-Orly airports. Tobacco products, electronic cigarettes, vaping products, telephony products, stamps and games of chance are not considered eligible purchases. Therefore, the purchase of these products (tobacco, electronic cigarettes, vaping products, telephony, stamps and games of chance) does not qualify for participation in the Game;
- At the checkout of a partner store listed in Appendix 1 of these rules, scan your "Extime Rewards" loyalty card and pay for your purchase. In the event that the participant refuses to pay for his/her purchase, or that the bank holding the participant's bank account refuses to pay, participation in the Contest will not be recorded;
- On the purchase confirmation e-mail (purchase in partner boutiques listed in Appendix 1 of these rules) sent by the Organizing Company to the "Extime Rewards" loyalty account holder, click on the link to access the Game in order to be redirected to the contest.game.extime.com website. The participant must find eight (8) hidden objects on the interactive map displayed on the screen;
- If the eight (8) objects hidden on the interactive map are found, complete the entry form by providing the mandatory information (surname, first name, e-mail address, date of birth, cell phone number, zip code, confirm that you have read and accepted these rules by ticking the appropriate box);
- Definitively confirm participation in the Game.

Any person contravening the provisions of these rules will be automatically excluded from the Game and will not be entitled to any claim on this ground.

Any fraud or attempt at fraud, the use of robots or any other process enabling participants to participate mechanically and/or intended to increase their chances of winning are prohibited. Any observation of such practices, of which the participant would be at the origin, will entail his automatic exclusion from the Game and this without being able to claim any right of complaint on this ground.

Participation in the Game implies that participants have carefully read and accepted these rules.

The Game is accessible only via the Internet. To take part in the Game, you must have a suitable Internet connection.

Participants are asked to check their inboxes and junk mail regularly.

3.4 Designation of prize winners

The winners of the prizes, the list of which is detailed in article 4.1.2 of these rules, will be determined in a draw to be held on June 18, 2024 at 12:00 p.m. (Paris time - France) by the Organizing Company.

- The sixth participant drawn at random will be designated "**Winner No. 6**" and will be awarded the prize described in article 4.1.2 of these rules;
- The seventh participant drawn at random will be designated "**Winner No. 7**" and will be awarded the prize described in article 4.1.2 of these rules;
- The eighth participant drawn at random will be designated "**Winner No. 8**" and will be awarded the prize described in article 4.1.2 of these rules;
- The ninth participant drawn at random will be designated "**Winner No. 9**" and will be awarded the prize described in article 4.1.2 of these rules;
- The tenth participant drawn at random will be designated "**Winner No. 10**" and will be awarded the prize described in article 4.1.2 of these rules;
- The eleventh participant drawn at random will be designated "**Winner No. 11**" and will be awarded the prize described in article 4.1.2 of these rules;

- The twelfth participant drawn at random will be designated "**Winner No. 12**" and will be awarded the prize described in article 4.1.2 of these rules;
- The thirteenth participant drawn at random will be designated "**Winner No. 13**" and will be awarded the prize specified in article 4.1.2 of these rules;
- The fourteenth participant drawn at random will be designated "**Winner No. 14**" and will be awarded the prize specified in article 4.1.2 of these rules;
- The fifteenth participant drawn at random will be designated "**winner n°15**" and will be awarded the prize specified in article 4.1.2 of these rules.

Article 4: Prizes

4.1 Prizes up for grabs

4.1.1 Total number of prizes to be won

The total number of prizes to be won is as follows:

- 15 X 2 tickets for the Paris 2024 Olympic Games taking place from July 26, 2024 to August 11, 2024* with a unit value of between €230.00 and €1,600.00 (Average price: €367.00).

* The dates, times and events covered by the tickets will be determined at random, according to availability, and communicated to the winners at a later date. Thus, it will not be possible to choose the type of ticket or the competition.

Under the terms of the Game, fifteen (15) participants will be drawn at random and declared winners.

4.1.2 Distribution of prizes per winner

- **For "winner n°3"**: two (2) tickets for the Paris 2024 Olympic Games - Swimming event - Men's and Women's Finals - taking place on August 4, 2024 from 6:30 pm to 8:30 pm at Paris La Défense Arena, worth €660 each;
- **For "winner n°4"**: two (2) tickets for the Paris 2024 Olympic Games - Equestrian Sports event - individual show jumping - Final - taking place on August 6, 2024 from 10am to 12pm at the Château de Versailles - worth €280 each;
- **For "winner n°5"**: two (2) tickets for the Paris 2024 Olympic Games - Tennis event - Men's Singles and Women's Doubles - taking place on August 4, 2024 from 12pm to 7pm at the Roland-Garros court Philippe Chatrier Stadium - worth €280 each;

- **For "winner n°6"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - Women's qualifications - taking place on July 28, 2024 from 2.50 pm to 4.30 pm at the Arena Bercy - worth €230 each;
- **For "winner n°7"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - Women's qualifications - taking place on July 28, 2024 from 2.50 pm to 4.30 pm at the Arena Bercy - worth €230 each;
- **For "winner n°8"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - Women's qualifications - taking place on July 28, 2024 from 2.50 pm to 4.30 pm at the Arena Bercy - worth €230 each;

- **For "winner n°9"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - Women's qualifications - taking place on July 28, 2024 from 2.50 pm to 4.30 pm at the Arena Bercy - worth €230 each;
- **For "winner n°10"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - Women's qualifications - taking place on July 28, 2024 from 2.50 pm to 4.30 pm at the Arena Bercy - worth €230 each;
- **For "winner n°11"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - All-around Final - taking place on July 31, 2024 from 5:30pm to 8:15pm at Arena Bercy - worth €250 each;
- **For "winner n°12"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - All-around Final - taking place on July 31, 2024 from 5:30 p.m. to 8:15 p.m. at Arena Bercy - worth €250 each;
- **For "winner n°13"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - All-around Final - taking place on July 31, 2024 from 5:30 pm to 8:15 pm at Arena Bercy - worth €250 each;
- **For "winner n°14"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - All-around Final - taking place on July 31, 2024 from 5:30 p.m. to 8:15 p.m. at Arena Bercy - worth €250 each;
- **For "winner n°15"**: two (2) tickets for the Paris 2024 Olympic Games - Artistic Gymnastics event - All-around Final - taking place on July 31, 2024 from 5:30 pm to 8:15 pm at Arena Bercy - worth €250 each.

The value of the prizes, indicated above, is given as an indication.

As stipulated in article 3.4 of these rules, the prizes are awarded at random.

The prizes are personal and may not be transferred to third parties. A participant may only be awarded one prize (same surname, first name, e-mail address and postal address).

In addition, a person may accompany a winner only once.

Participants may not claim any compensation or payment of the difference between the actual value and the indicative value. Furthermore, participants may not claim payment by the Organizing Company of the equivalent value of their prize in euros. Prizes are not exchangeable, refundable or modifiable. They may not be the subject of financial consideration.

The prizes are limited to their designation. Consequently, no additional costs or services may be requested by the winners from the Organizing Company. Any such additional costs or services will be the sole responsibility of the winner (including, but not limited to, transportation, meals, accommodation, etc.).

4.2 Delivery of prizes

Once the draw has been made, the winners will be contacted by the Organizing Company within ten (10) days directly by e-mail. Within a maximum of seven (7) days after the Organizing Company has sent the said e-mail, the winners must confirm their interest in the prizes they have won.

Participants are advised to check their e-mail inboxes and junk mail regularly.

Then, a few days before the competition, the Paris 2024 Organizing Committee for the Olympic and Paralympic Games (COJOP) will send the tickets to the winners via the "Paris 2024 Tickets" smartphone application. A secure QR code will appear on the tickets just a few hours before the event to prevent forgery. These QR code tickets will be the only means accepted by staff at event entrances. No printouts or screenshots will be accepted by ticket verification and validation staff.

Unless otherwise specified by the Paris 2024 Organizing Committee for the Olympic and Paralympic Games (COJOP), tickets can only be transferred twice (2) via the "Paris 2024 Tickets" smartphone application. If a winner wishes to transfer a ticket to a relative, the procedure is as follows:

- Go to the "Paris 2024 Tickets" application;
- Click on "Transfer" under the ticket you wish to transfer to a relative;
- Confirm the transfer and make sure it's the right ticket;
- Confirm the desired delivery mode;
- Share the download link with your beneficiary;
- Confirm the transfer (you can always cancel the transfer as long as the beneficiary has not accepted it);
- Your ticket is now being transferred! Once the beneficiary has accepted the transfer, you'll be notified (remember to activate notifications on your application to keep up to date with your ticketing news).

The resale of prizes is strictly forbidden.

The Organizing Company is in no way responsible for the delivery of the prizes. Therefore, the Organizing Company will not be able to send the prizes by e-mail, post or any other means.

The Organizing Company cannot be held responsible if the winners and their respective companions are unable to connect to the "Paris 2024 Tickets" smartphone application.

To gain access to the events, holders of tickets allocated on the "Paris 2024 Tickets" smartphone application must be prepared to undergo an identity check during which their identity must match the first and last names on their ticket. Winners and their respective companions are required to consult the Paris 2024 regulations available on the "Paris 2024 Tickets" smartphone application.

4.3 Unclaimed or unrecovered endowments

If the winner does not reply to the e-mail sent by the Organizing Company within the time limit mentioned in the first paragraph of article 4.2 of these rules, the winner will lose the prize. If time permits, the prize will be put back into play and a new winner will be drawn at random from among the losing participants. In the absence of sufficient time, the prize will not be put back into play.

It is specified that the winner is solely responsible for taking the necessary steps to collect his/her prize via the "Paris 2024 Tickets" smartphone application. The Organizing Company may not be held responsible if the winner has not taken the necessary steps.

Furthermore, if for any reason whatsoever, the winners and/or their respective companions do not wish to or are unable to benefit from their prize, they may not claim any reimbursement, compensation or consideration of any kind.

Any incomplete, erroneous or falsified information, or information that does not enable a participant to be identified or located, will result in the cancellation of his/her/their participation. 4.5 Miscellaneous

The Organizing Company will not provide any additional services concerning the prizes.

The Organizing Company shall not be liable for any damages arising from the use of the prizes by the winner(s).

The Organizing Company reserves the right, for any reason whatsoever, to modify, extend, shorten, suspend or cancel the Contest, without incurring any liability as a result. In such a case, the Organizing Company reserves the right to replace the prizes with products of lesser, equal or greater value in the event that the said prizes are unavailable, without the participant being able to make any claim in this regard.

Should a winner win several prizes, the Organizing Company reserves the right to cancel all or part of these prizes at any time.

No email, letter or message in general will be sent to the losers of the Game.

Personal data collected includes surname, first name, email address, date of birth, zip code, cell phone number.

The data collected will be treated as confidential and will only be used for the purposes of the Game. No personal data will be sold, shared or disclosed to third parties, except to Artefact within the framework of the Game, without the explicit consent of the participants, except in the cases provided for by law.

Participants' personal data will be kept for a period of four (4) months from the end of the Game. Once this period has elapsed, the data will be deleted in accordance with current legal and regulatory obligations.

To exercise their rights (access, rectification, deletion, limitation of the processing of your data, as well as their portability), participants may contact the Data Protection Officer of the Organizing Company by e-mail: informatique.libertes@adp.fr.

Participants may contact the Commission Nationale de l'Informatique et des Libertés (CNIL) if, after having contacted the above-mentioned Data Protection Officer, they feel that their data rights have not been respected.

The Organizing Company may not be held liable for any prejudice of any kind (personal, physical, material, financial or other) arising from a participant's participation in the Game.

The Organizing Company reserves the right to shorten, extend or cancel the present Contest in part or in its entirety should circumstances so require, notably in the event of an overriding reason. It shall not be held liable for any such changes. Such changes may, however, be notified in advance by any appropriate means.

Participation in this Game implies full and unreserved acceptance of these rules and of the rules of good conduct on the Internet.
